3. To aid in the accurate description of your horse on its Certificate of Registration please take the following photographs as specified below:
  - We recommend that you do not use a camera that produces instant photos.
  - Take photos from front, back and both sides of horse and make sure that horse does not blend into the background.
  - Take photos with horse standing on flat, dry surface and make sure you have a clear view of legs through viewfinder.
  - Take photographs with sun at your back. (avoid horse standing in shadows)
  - Take extra photos of all unusual markings and move forelock aside when photographing facial markings if needed.

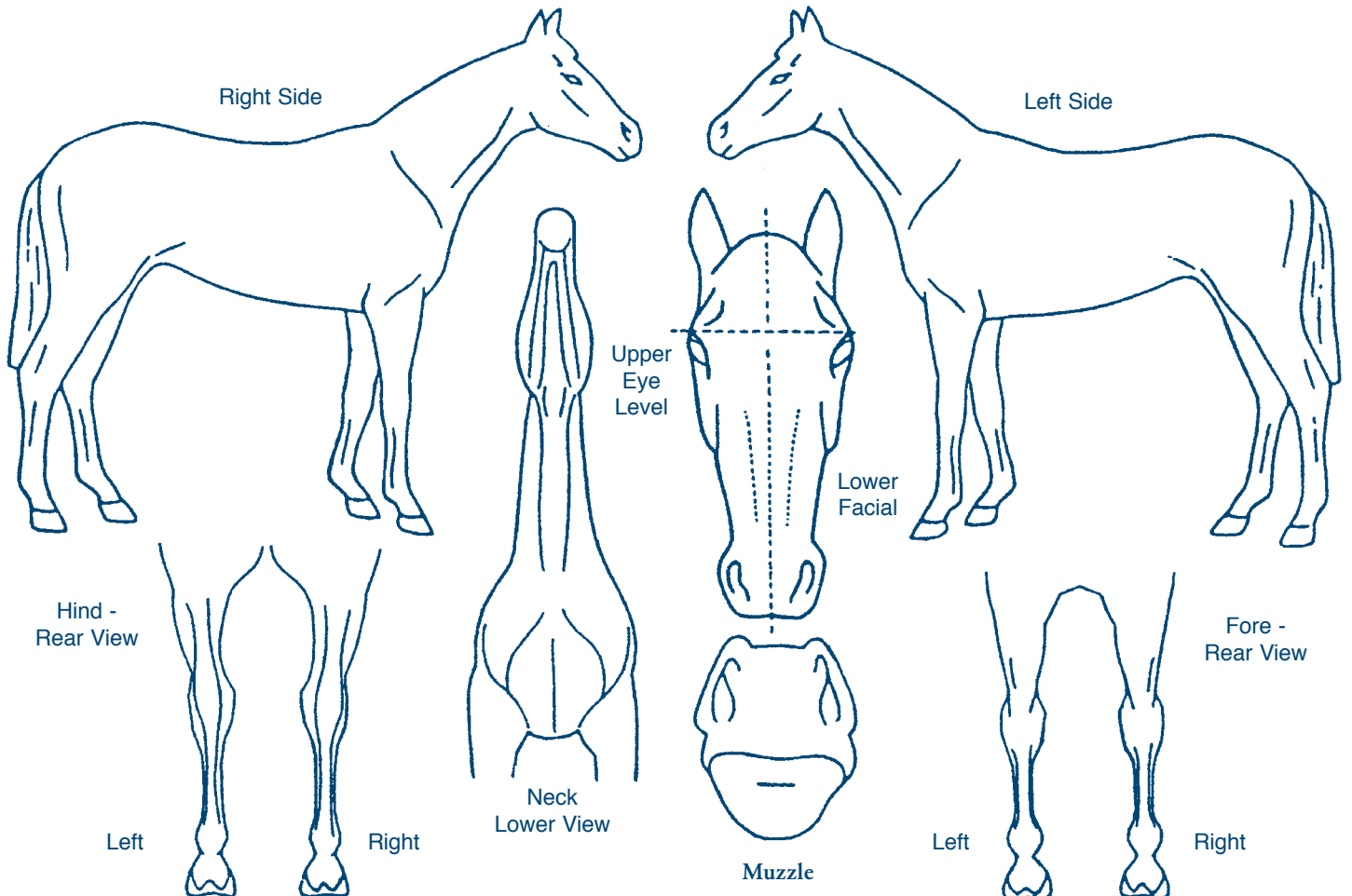
